# MEMORANDUM OF UNDERSTANDING between the FOLSOM CORDOVA UNIFIED SCHOOL DISTRICT and the FOLSOM CORDOVA EDUCATION ASSOCIATION

### Summer School during the 2022-2023 School Year

Folsom Cordova Unified School District and Folsom Cordova Education Association enter this Memorandum of Understanding ("MOU") regarding the issues related to summer school during the 2022-2023 school year. The mutual goal is to provide the best possible learning opportunities for all students. This agreement only applies to 2022-2023 summer school and shall not be precedent setting for future contract negotiations.

Unless otherwise noted below, the provisions of this MOU shall supersede any provisions of the Collective Bargaining Agreement between the Parties that are in conflict for the duration of this MOU, or until modified by mutual agreement of the District and the Association. The Parties affirm the obligation to comply with all provisions of the Collective Bargaining Agreement ("CBA") not in conflict with this MOU.

### **ARTICLE 1:**

#### 1.0 Stipends

- 1.1 Secondary Summer School Teachers: (Cordova High School; depending upon enrollment)
  1 Professional Development Day (June 1)
  14 days of Summer School (June 5-June 23; no school 06/19)
  5 days per week
  4.25 hours per day (8:30 am 12:45 pm)
  \$246.97 x 15 = \$3,705 stipend
- 1.2 Secondary Summer School Counselors: (Cordova High School; depending upon enrollment) 5 days outside of contract (includes 4-day building master schedule and planning) 12 days of instruction (June 7- June 23; no school 06/19) 5 days per week
  4.25 hours per day (8:30 am 12:45 pm) \$271.66 x 17 = \$4,618 stipend
- 1.3 ESY Preschool Teacher: (depending upon enrollment: NSE, NE) 1 Professional Development Day (June 1) 20 days of instruction (June 2- June 30; no school 06/19) 5 days per week 3.75 hours per day (8:30 am - 12:15 pm) \$224.44 x 21 = \$4,713 stipend
- 1.4 ESY Teacher: (depending upon enrollment: NSE, NE)
  1 Professional Development Day (June 1)
  20 days of instruction (June 2- June 30; no school 06/19)
  5 days per week
  4 hours per day (8:30 am 12:30 pm)
  \$239.40 x 21 = \$5,027 stipend

1.5 Related Service Providers ESY (i.e. Nurses & SLPs)
1 Professional Development Day (June 1)
20 days of instruction (June 2- June 30; no school 06/19)
5 days per week
4 hours per day (8:30 am - 12:30 pm)
\$255.68 x 21 = \$5,369 Stipend

## **ARTICLE 2:**

- 2.0 <u>Duration</u>
- 2.1 The Parties share joint interests in keeping communications open and working collaboratively for the benefit of students, staff, parents, and the District community as events continue to unfold during the pandemic.
- 2.2 This MOU shall expire in full without precedent on July 1, 2023, unless extended by mutual written agreement of the Parties.
